Emergency Action Plan website: http://eap.pork.org	The emergency action plan tool guides producers through the planning and documenting of an emergency response plan. The tool is Web-based and can be found online at https://eap.pork.org/ . Users are instructed to log in, describe their operations and consider various situations that can put a farm's employees, animals or facilities at risk. Users also are required to think about and describe the resources, including people, equipment and locations, that can be of use in case disaster strikes.
